\_\_\_\_\_ **Seasonal Storage Agreement**

I understand the storage fee for boats, cars, pontoons, trailers, etc. is \$10.00 per linear foot will be measured from front to back including trailers (measured by fair board). Items may be placed in storage before October of each year with special appointment.

The seasonal fee is non-refundable. The Gladwin County Fair board will exercise due care for the protection and safety of all property stored under its supervision. However, the fair board will assume No responsibility for the damage, loss or theft of any property. The fair board will require that you show verification by insurance policy on the items listed above at the time the item is placed in storage or if no Insurance must be noted. Campers will be pulled on first storage out day and will be outside till there are picked up. **No campers will be put back in storage after 3<sup>rd</sup> Saturday of April of each year.**

The Gladwin County fair board may order the removal of any stored item at any time, but a pro-rated refund will be issued for the remaining storage season. If you want your item out on a special day and arrangements are not made to get item out on special day there will be a charge.\$75.00 per hour for plowing, man power to take items in and out of building min 3 people. **All units will be paid for at time of drop off.**

A \$30.00 deposit holds your spot until storage time (non-refundable after September 1).

Spots not filled by November 1, are automatically voided and can be resold.
